





#### **CAN DASHBOARD - KEY CONSIDERATIONS**

Community-wide indicators don't tell all the story.


Viewing the data by race/ethnicity often tells a different story. The drill-down on our on-line dashboard can help.

Demographic shifts are affecting economic indicators as much (or more) as effortsto address persistent challenges.


We're still looking for changes to pandemic-era shifts in demographics and outcomes (are they persistent?).

#### A CHANGING ECONOMIC LANDSCAPE

About 21% of all people living in the five-county Austin MSA were low-income in 2022. "Low-income" is defined as people who live in a household with total earnings of less than 200% of the Federal Poverty Threshold. In 2022, low-income households earned up to \$59,356 for a family of four with two adults and two children, and \$47,156 for a family of three with one adult and two children. From 2012 to 2022, the Austin MSA grew by 588,166 people, surpassing 2 million people in 2015. This represents a growth of 33%. The number of low-income residents declined by almost 87,000 in the Austin MSA, a 15% reduction over the same time period.




#### **COMPARING MSA COUNTIES**

Between 2012 and 2022, the low-income population decreased in the overall Austin MSA. In Travis County, low-income resident numbers dropped by 25%. Meanwhile, the low-income population decreased by 2% in Hays County and by 1% in Williamson county. In Bastrop County, the number of low-income residents increased by 53%. The estimated changes for Hays and Williamson County were not significantly different at the 90% confidence interval.

Caldwell County, the fifth county in Austin's 5-county MSA, isn't represented in the table because ACS 1-Year data is unavailable. The most recent estimate available for Caldwell County is an American Community Survey 3-year estimate for 2011-2013.



#### WHERE DO WE STAND?

Over the five-year period from 2018 through 2022, the property crime rate in Travis County decreased by 1%. However, the number of auto thefts more than doubled over the same period. Over the past 5 years, larceny/thefts decreased by 5%, while burglaries increased by 3%. We would note that the property crime rate in Travis County decreased by 7% from 2020 to 2021.

#### WHERE DO WE STAND?


The violent crime rate in Travis County increased by 5% from 2021 to 2022 and by 24% from 2018 to 2022. However, the Travis County violent crime rate remains lower than the rate for Texas urban counties. Over the 5-year period from 2018 to 2022, the total number of rapes decreased by 28%, robberies decreased by 4%, while murders increased by 116%, and assaults increased by 65%.

## 15% of Travis County residents ARE FOOD INSECURE

#### WHERE DO WE STAND?

Approximately 15% of Travis County residents faced food insecurity in 2022. That means they had limited or uncertain availability of nutritionally adequate and safe foods, according to <u>Feeding America</u>, the nation's leading domestic hunger-relief charity.

Children are more likely than adults to experience food insecurity. According to Feeding America, 17% of children in Travis County experienced food insecurity in 2022. Furthermore, the rates for African Americans (27%) and Hispanics (21%) are over twice the rate for Whites (10%).







\*The US Census Bureau did not release 2020 ACS 1-Year data. To estimate the 2020 housing cost burdened rate, the median between the 2019 and 2021 rates was used.

#### WHERE DO WE STAND?

The U.S. Department of Housing and Urban Development (HUD) recommends that households pay no more than 30% of total income on housing. More than 1 out of 3 households in Travis County do not meet this affordability threshold. The number of households who were housing cost burdened in Travis County in 2022 was 193,519, compared to 167,617 in 2018 (a 15% increase).

Renters are cost burdened at a rate that is almost twice that of homeowners. Low-income renters are most impacted.


